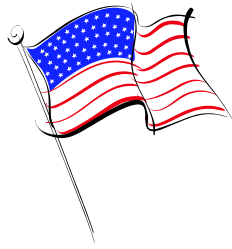

Booth Setup Information

—PLEASE KEEP—



Pre-Registration is July 3rd, 2009 at Pfaff Park—All Vendors must register at the park between 9:00am–12:00pm.



Booth Setup can begin after 4:00pm on July 3rd, 2009. NO security is stationed at the park on July 3rd, so we encourage you to ONLY setup tents.



Booth Teardown is 4:00pm or after on July 4th. Absolutely no teardowns before 4:00pm or you may not be asked back the following year. This is for the benefit of the event. It looks like the festival is over when vendors begin to teardown.



All Food Vendors must provide a garbage can with liner and you must pick up and throw away any garbage in and around your booth. Make sure at all times your cans are not overflowing. Please tie up and deposit trash in the garbage containers provided by the City of Central Point.



Vendors Must Conform to Fire District 3 regulations. Fire District regulations are available from the Chamber office.



We Recommend All Vendors display an American Flag at their booth.



Locations Cannot be Guaranteed, but if you have a request, please let us know.



Electricity: As you may know, we are limited on electricity at Pfaff Park. If you have a generator and you can use it, PLEASE let us know. This will avoid the dreaded electrical tripping.
